








## Meet your school governing board

	<p><b>Ann Nicholson (Co-opted Governor &amp; Chair of Governors)</b>  <i>Lead for Safeguarding, Data &amp; Improvement, Curriculum and Whistleblowing</i></p> <p>I moved to Cornwall from Surrey with my late husband in 2001. Before taking early retirement I taught in a Church of England Primary School in London for 35 years. Although I did not know at the time both my grandmother and husband had been pupils there. Later my own two children attended my school. Following my retirement, I volunteered in my old school and helped children with reading, ICT, visits and camps. Soon after our move to Launceston I volunteered to hear readers at St Stephens and eventually became a governor and later Chair. I resigned from the Governing Body of St Stephens a couple of years ago as I thought it needed some new faces and ideas. I then became a Member of Andaras MAT. However my interest in St Stephens continued and I offered to become a Governor again last year. Apart from my involvement with St Stephens, I enjoy reading, listening to music and walking my two dogs. I am an active member of Launceston U3A and am involved in my local community. My daughter is a teacher in New Zealand, so I try to visit her and my grandchildren whenever I can. St Stephens is a great school and I am proud to be associated with it.</p>
	<p><b>Sue Tierney (Co-opted Governor)</b>  <i>Lead for PPG &amp; PE (provision &amp; impact)</i></p> <p>I was born in Reading, Berkshire and grew up in a village a few miles away. I moved to Cornwall nearly 25 years ago after being a civil servant at the Atomic Weapons Research Establishment. Ten years ago I received my second degree, a Bachelor of Education (Maths) and I taught in a number of schools for a few years. I retired early after being run over by a car. I am a member of St Mary's Church in Launceston where I sing in the choir. I also sing in the Choral Society. Church work includes being a member of the Church Committee, being treasurer, running Kids' Cafe, helping at Messy Church and, of course, Open the Book. 	<p><b>Kathy Walsh (Staff Governor)</b>  <i>Lead for Strategy, Stakeholders &amp; Curriculum</i></p> <p>I have been at St Stephens Community Academy since February 2018. I work in the Area Resource Base, teaching pupils with complex needs. It is a real honour to be working with these young people who face incredible challenges daily. I feel so lucky to have spent over twenty years working in some amazing schools in Cornwall with wonderful staff dedicated to providing the very best education and exciting experiences for all our children. During my time as a teacher, I have held a range of roles including Co-ordinator for English, Maths, Science, Assessment, Assistant Headteacher and SENDICO- achieving the National Special Educational Needs Qualification alongside becoming a Thrive practitioner. In a previous life, before I became a teacher, I worked on The Western Morning News and Plymouth Evening Herald, based in Plymouth.</p> <p>I am mum to two boys, both of whom are at Launceston College. I am a member of Launceston Medical Centre Patient Participation Group (PPG), a lay member of the Citizens Advisory Panel (an independent voice in the work of the Cornwall and Isles of Scilly Health and Care Partnership) and an Independent Custody Visitor working out of the Office of the Devon and Cornwall Police and Crime Commissioner. I was a Parent Governor at my daughter's school in Reading in the 1980s and I have an ongoing interest in education and equal opportunities for all our young people.</p>
	<p><b>Robyn Iveson-Mills (Parent Governor)</b></p> <p>I am a registered mental health nurse and have been working within a variety of CAMHS settings for the past 13 years, as I have a passion and dedication for working with vulnerable, complex and high-risk children and young people with mental health and support needs. I believe the school setting is an integral part of promoting a child and young person's health, wellbeing and development, and would like the opportunity to continue supporting this age group, but with a different focus and from a different perspective (as a parent) than my day-to-day role. My daughter attends the Academy, and I would like to support not only her education, but that of the other pupils to ensure they are getting the best education, opportunities, and overall experience from the school.</p>

<p><b>Overview</b></p> <p>Their overall role is ensuring robust accountability and oversight of the school. They help to ensure clarity of the vision &amp; ethos of the school, and they hold the school leadership to account for the educational performance, development and well-being of its pupils. They ensure that the school is committed to continuous improvement and take account of the views &amp; needs of pupils, staff, parents and carers.
